RULES AND CONDITIONS OF PARTICIPATION

- 1) You can participate in the application phase if you are at least 18 years old and come from, live in the regions of Bremen, Groningen, Hamburg or Oldenburg. The application is free of charge!
- 2) With your application, you confirm that you agree and accept the rules of the project.
- 3) Since not all funds are granted yet, the exact number of artists have not yet been determined. So far we can not pay any honorarium, travel budget, accommodation or delivery costs.
- 4) We have a mixed selection process, which is based on an internal points system in the first round and a jury decision in the second round.
- 5) You hereby give your permission for to use your work that will be created within the project, for advertising purposes of the re:claim festival and to promote The Hidden Art Project. Further you allow us to use images, sound and video recordings of you and your work made during all phases of the event for advertising purposes of the re:claim festival and to promote The Hidden Art Project.
- 6) We use your personal data exclusively for the purpose of carrying out this project.
Your application should consists of the following parts:
 - A short but expressive description (preferably with a picture) in the form of text or video of you or your collective (the content is more important than the quality of the video),
 - the signed data protection declaration/registration form (one form per person).Only for the Roomers, gallery or event applications:
 - a document with links to your homepage(s), projects and/or also
 - videos (as a link) and/or images of your work (max. 5 artworks, all images no larger than 10 MB please).

Only for the Roomers applications:

- 7) The Roomers project will take place over four phases. After acceptance by The Hidden Art Project, the participation in each of these phases is compulsory. Exceptions can only be made in individual cases.
Phase 1 is the application till 22.05.22.
Phase 2 is a 2-day workshop in Oldenburg on 28 & 29.05.22, where we will get to know each, exchange our ideas, find groups and concretise the ideas that have arisen.
Phase 3 is from 09.06.22 to 16.06.22: the set-up and rehearsals for the event will take place.
Phase 4 is from 17.06.22 to 26.06.22: The exhibition itself

- 8) The installations created will become the property of The Hidden Art Project after completion of the construction phase. There is no entitlement to a share of the payment. Exceptions can only be made in individual cases.

Only for gallery or event applications:

- 9) We reserve the right to exclude applications if the following requirements are not met:
 - You own the copyright and are the creator of the artwork.
 - You have the right, also in relation to third parties, to submit the artwork/s.
 - You make sure that your submission do not contain any political, religious, sexist, youth-endangering and/or racist content. If the art violates common decency, the criminal law we are entitled to refuse the artwork. Advertising for political parties, religious groups, and politically motivated organizations as well as for private purposes and for the purpose of expressing private or political opinions is subject to approval in any case.
 - To the best of your knowledge, the submission does not contain any material that constitutes or encourages conduct that would be considered a criminal offense or otherwise violate applicable law.
 - The submission does not infringe in any way on the copyrights, trademark(s), or intellectual property rights of any third party and in particular does not contain any:
 - Trademarks owned by third parties,
 - Materials that third parties have copyright protected or references such as names, visual similarities or similar to living or deceased celebrities or other public figures.

Only for gallery applications:

- 10) If your image or parts of your submission are selected, we will curate it/them into a collective exhibition. There is no entitlement to co-determination of the positioning. The latest delivery date for the artworks will be communicated immediately after the selection process. Latest delivery date is 10.06.2022. All selected artwork will remain part of the exhibition until the end of the gallery project at

the re:claim festival and cannot be removed or exchanged before the end of the exhibition on 26.06.2022 at 23:59h.

11) All artworks will be marked with the title and name of the artist. We reserve the right that the labelling does not have to be done in a direct immediate vicinity of the work and can also be done in a centralised manner and/or through technical solutions.

12) The Hidden Art Project does not bear any liability and claims for compensation for damage or theft for the selected paintings. The liability for the exhibited objects is assumed by the artists themselves.

13) After the end of the exhibition project in the context of the re:claim festival on 26.06.2022 at 23:59h, the artwork/s must be collected at your own expense before 03.07.2022 at 16h.
